Privacy Policy

This privacy policy aims to inform you about how your personal data is collected, processed, and protected on the *pastely.art* website, in accordance with the Swiss Federal Act on Data Protection (FADP).

1. Data Controller The data controller is: Alexis Pavret de la Rochefordière Email: contact@pastely.art

2. What data do we collect and why? We collect and process your data solely for the proper functioning of the site and the services offered:

- **Standard account creation:** We store your email address, a username and your profile picture
- **Google Login (SSO):** If you choose to log in with Google, we retrieve and store your Google ID, your email address, and your profile picture to identify you on our platform.
- **Payments and Subscriptions:** Payments are secured and managed by our third-party provider, Stripe. We do **not store any banking data** (neither credit card numbers nor bank accounts). We only keep technical identifiers (Stripe Customer ID and Stripe Subscription ID) to link your *pastely.art* account to your purchase or subscription.
- **Contact:** If you contact us by email, we will use your address solely to reply to you.
- **Newsletter:** If you choose to subscribe to it, we will use your email to send you our news. You will be able to unsubscribe at any time via a link at the bottom of each email.

3. Analytics Tools and Cookies We are committed to respecting your privacy. That is why we use **Umami**, a privacy-friendly traffic analysis tool.

- Umami is hosted locally on our own servers.
- It does not collect any personally identifiable data and does not use intrusive tracking cookies.
- The statistical data generated (pages visited, clicks) belongs exclusively to us and is never shared with advertising networks.

4. Data Sharing with Third Parties Your data is never sold. It is only shared with technical service providers strictly necessary for the operation of the website:

- **Stripe** (for secure payment processing).
- **Google** (only if you use the Google login feature).

5. Hosting and Security The *pastely.art* website and its database are hosted locally (self-hosted). We implement the necessary technical measures (password encryption, secure access) to protect your data against any unauthorized access.

6. Your Rights In accordance with the FADP, you have the following rights regarding your personal data:

- Right of access (to know what data we hold about you).

- Right to rectification (to correct inaccurate data).

Terms of Service and Sale (TOS)

These terms govern the use of the *pastely.art* website and the purchase of subscriptions offered by Alexis Pavret de la Rochefordière (hereinafter "the Publisher"). By creating an account and using our services, you accept these conditions in their entirety.

1. Purpose of the Service *pastely.art* provides an online digital tool. Basic access may be free or limited. The Publisher offers a paid monthly subscription allowing users to benefit from a higher usage limit for this tool.

2. User Account To subscribe to a plan, the user must create an account.

- The user agrees to provide accurate information.
- The user is responsible for maintaining the confidentiality of their password and account access. Any activity conducted through their account is deemed to have been performed by the user.

3. Subscription and Payment

- **Pricing:** Subscription prices are displayed on the website at the time of subscription.
- **Renewal:** The subscription is on a monthly basis. It automatically renews each month on the anniversary date of the subscription unless canceled by the user before this date.
- **Payment:** Payments are made via credit card through our secure payment provider, Stripe. The Publisher never has access to the user's full banking details.

4. No Right of Withdrawal and Refunds By subscribing to *pastely.art*, the user is granted immediate access to intangible digital content and services. Therefore, the user expressly agrees that the service is executed as soon as the order is validated and waives any right of withdrawal. **No refunds, even partial, will be issued for any started subscription period.** However, the user may cancel the automatic renewal of their subscription at any time from their account settings.

5. Service Availability ("As Is" Service) The *pastely.art* tool is provided on an "as is" basis. The Publisher endeavors to keep the website accessible 24 hours a day, 7 days a week, but is under no obligation of result. Access to the site may be temporarily suspended for maintenance, updates, server outages, or in the event of force majeure. The Publisher disclaims all liability in the event of data loss or damages related to a temporary unavailability of the tool.

6. Rules of Conduct The user agrees to use the *pastely.art* tool in a reasonable and lawful manner. Any attempt to hack, bypass the tool's usage limits, or use automated tools (bots) to overload the servers will result in the immediate suspension of the account without prior notice, and with no possibility of a refund.

7. Intellectual Property The code, design, interface, and concept of the *pastely.art* tool remain the exclusive property of the Publisher. The subscription only grants a limited, personal, and non-transferable right to use the tool.

8. Applicable Law and Jurisdiction These terms and conditions are governed by Swiss law. In the event of a dispute that cannot be resolved amicably, the exclusive place of jurisdiction shall be the competent courts of the Canton of Vaud, Switzerland (the Publisher's place of residence).
